



TouchChat Trainer Program Terms and Conditions

The TouchChat Trainer Program (the Program) is offered by Prentke Romich Company d/b/a PRC-Salttillo (PRC-Salttillo) to licensed and degreed professionals within the field of Augmentative and Alternative Communication (AAC). Employees, contractors, or agents of companies who manufacture, sell, or distribute AAC devices and materials (except for Authorized App Resellers) are not eligible to apply or participate in the TouchChat Trainer Program. This agreement does not represent an employment or agency agreement between PRC-Salttillo and the Applicant.

By applying for the Program, you agree to abide by these Terms and Conditions as they apply to the TouchChat Trainer Program. Any promises or terms not included herein are expressly excluded.

Upon acceptance of an application and processing of Program fees, PRC-Salttillo agrees to provide initial training on the TouchChat Application.

Upon successful completion of the Program requirements, as determined by PRC-Salttillo, PRC-Salttillo agrees to provide:

- A certificate naming the participant as a TouchChat Trainer;
- Support services including an initial period of phone support and materials;
- Periodically updated training, as determined by PRC-Salttillo;
- A license and permission to offer training to others on the TouchChat App.

The Applicant agrees to the following:

- That you allow your information to be listed on the TouchChat website and that you understand that you may be contacted by customers about providing trainings in your area;
- To update PRC-Salttillo if, at any time, your information changes;
- Attendance at and completion of the provided courses;
- That you are not an employee, contractor, or agent of any company that manufactures, sells, or distributes AAC devices and materials and that you will immediately notify PRC-Salttillo if that status changes.
- To remain knowledgeable of and include only current features of the TouchChat Application within offered trainings.
